

# Announcement of Walailak University

# Conditions for Implementing English Proficiency Test Scores Transferring to Grade (General Education Curriculum) Revised in 2021

.....

To appoint conditions for implementing Englishproficiency test scores transferring to grade (General Education Curriculum) for both Thai and international students in all learning systems effectively and follow the same guidelines correctly.

Therefore, by virtue of section 24 of the Walailak University Act A.D.1992 together with Academic Council of Walailak University, No. 9/2021, on September 15, 2021, the Walailak announcement of Conditions for Implementing English Proficiency Test Scores Transferring to Grade (General Education Curriculum) Revised in 2021, issued on August 30, 2021 were canceled and this announcement is declared as follows,

**Item 1.** The announcement will be implemented for student ID 64 onwards.

Item 2. Both Thai and international students of all learning systems who have a score of WUTEP greater than or equal to 33.5 or other equivalent tests according to the 1st and 2nd attachments of the announcement will be able to enroll for English language courses in the General Education courses. However, if students have a score of WUTEP less than 33.5 WUTEP or other equivalent tests according to the 1st and 2nd attachments of the announcement, they must take the course GEN64-021/GEN64-021E/GEI64-021 English Foundation and must pass this course examination before being able to enroll in English courses of General Education curriculum.

**Item 3.** Implementing English proficiency test scores transferring to grade (General Education Curriculum) is able to apply as follows,

3.1 Both Thai and international students of all learning systems who have TOEFL (Paper-Based) scores greater than or equal to 498 points, or IELTS scores greater than or equal to 6 points, or WUTEP scores greater than or equal to 73.5 points, or other equivalent tests according to the 1st and 2nd attachments of the announcement are able to exempt from studying and receive grade A in all three General English courses as follows:

- 1. GEN64-121/ GEN64-121E/ GEI64-121
- 2. GEN64-122/ GEN64-122E/ GEI64-122
- 3. GEN64-123/ GEN64-123E/ GEI64-123

3.2 Both Thai and international students of all learning systems who have TOEFL (Paper-Based) scores between 453-497 points, or IELTS of 5.5 points, or WUTEP between 63.5-73 points, or other equivalent tests according to the 1st and 2nd attachments of the announcement, are able to exempt from studying and receive grade A in two General English courses as follows:

- 1. GEN64-121/GEN64-121E/GEI64-121
- 2. GEN64-122/GEN64-122E/GEI64-122

3.3 Both Thai and international students of all learning systems who TOEFL (Paper-Based) scores between 417 - 452 points, or IELTS equals 5 points, or WUTEP between 59 - 63 points or other equivalent tests according to the 1st and 2nd attachments of the announcement, are able to exempt from studying and receive grade A in one General English course as follow:

#### GEN64-121/GEN64-121E/GEI64-121

3.4 International students who are nationals of a country where English is the first language can waive all three General English courses without presenting a certificate certifying English language scores and received grade A in all three General English courses as follows:

- 1. GEN64-121/GEN64-121E/GEI64-121
- 2. GEN64-122/GEN64-122E/GEI64-122
- 3. GEN64-123/GEN64-123E/GEI64-123
- Item 4. Englishtest scores or other equivalent test results according to the 1st and 2nd attachments of the announcement must be valid for two years only since the score reported date.
- Item 5. The English test scores must be shown on the certificate which is issued by the test provider according to the 3rd attachment of the announcement. Furthermore, the certificate must have the official name surname, photo, score and scorereported date obviously.
- Item 6. All standardized English proficiency tests result according to the 1st and 2nd attachments of the announcement are accepted from dulycertified and test centers licensed by test provider providing the tests according to the 3rd attachment, and the test takers must present the valid document such as ID card or passport to verify themselves upon taking the test. The test must be proctored by invigilators assigned by the test center.

Item 7. Any test aside from what is in the table according to the 1st and 2nd attachments of the announcement will not beaccepted. Although the test provider states that the test results are equivalent to the scores of any English proficiency tests in this announcement, for example, "Student A completed the ABC test from D's institute and received 70 out of 100 scores, and the institutestates that the score of Student A is equivalent to CEFR's B2. However, ABC test scores are not taken into account consideration because the ABC test is not considered a CEFR exam".

Item 8. Anystudent who proposes Common European Framework of Reference for Languages (CEFR) score, the score will be considered from the lists of test creator and providers according to the 3rd attachment only. Additionally, the score will be calculated from the lowest score of each level according to the 1st and 2nd attachments of the announcement, for example, "If student A got B2 level of CEFR test, the equal score of each test such as IELTS will be equal 5.5, or TOEFL IBT will be equal 46 - 59, or TOEIC will be equal 785 - 835 and so on"

**Item 9.** Students can propose the English proficiency test scores before the last day of the course.

Item 10. Student who presents the English proficiency score stated in the guideline after the grades were announced by the university will not be allowed to change their obtained grade, for example, "Student X got a grade of Bin GEN64-121 at the end of the first term. During the term break, student X took an IELTS test and got a score of 5.5 and presented the evidence to the university. Student X will be allowed to waive his study in GEN64-122 and get grade A for the subject in the second term. However, the B grade of student X in GEN64-121 will remain the same.

Item 12. However, finding the notified points of disagreement insufficient or illegitimate, the president's decision shall be deemed as final.
